SUBJECT: **Genesee County Solid Waste Management Plan Amendment Approval**

The Department of Environmental Quality (DEQ) has completed their review of the Genesee County Solid Waste Management Plan Amendment. Staff received a letter from the DEQ, dated December 9, 2014, in which they identified modifications recommended in order to receive final DEQ approval. Staff recommends these modifications be approved.

Staff recommends an additional modification on page 55 (Facility Description for Richfield landfill), by adding the following statement, thus memorializing the County's intentions:

"If Genesee County gains ownership of the property, it does not intend to use the property for waste disposal."
