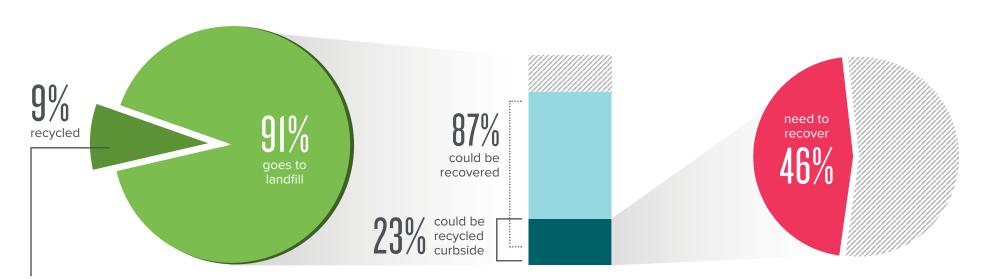

CURRENT STATE OF RECOVERY

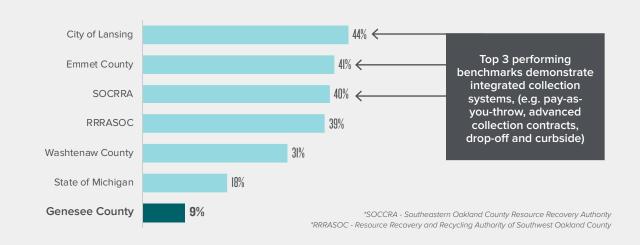


Genesee County's diversion rate (recycling + composting) is currently **9%.** This means **91%** of materials collected are going to the landfill.

Of the material being landfilled, **87%** could be recovered. **23%** are **curbside recyclables** (paper, metal, glass, cardboard, plastic).

In order to support a Materials Recovery Facility (MRF), Genesee County would have to recover **46%** of the **curbside revelables** that wound up in **the landfill.**

WHERE DOES GENESEE COUNTY NEED TO FOCUS TO IMPROVE RECOVERY OF CURBSIDE RECYCLABLES?

The solid waste management system was compared to national best practices of well functioning materials management systems.



COLLECTION: 33%

Below average due to low households with carts and lack of multi-family access.



PROCESSING: 40%

Below average due to limited processing capacity in County and distance to out-of-county MRFs.



FND MARKETS: 75%

Above average due to local recycling end markets (paper mills using recovered paper, plants using recovered plastics, etc.) in Michigan and the Midwest.



SUPPORTING POLICIES: 33%

Below average due to limited policies to encourage recycling.



EDUCATION & OUTREACH: **67%**

Average score due to GCMPC education activities which can be strengthened with funding and coordination.



PUBLIC PRIVATE PARTNERSHIPS: 10%

Well below average due to lack of leveraging partnerships

COMPARED TO NATIONAL BEST MANAGEMENT PRACTICES, GENESEE COUNTY SCORES BELOW AVERAGE IN SEVERAL KEY AREAS.

To improve the efficiency and effectiveness of recycling in the near term, RRS has developed a phased roadmap to increase single stream recycling
